Specifically, these tools that can be used for early identification of Learning Disabilities (LD) which leads to early intervention that can dramatically increase the child's chances for success in school.

Dr. Abu-Hamour is an **Associate Professor** in the Department of Counseling and Special Education at Mutah University, Al-Karak, Jordan. He received his Ph.D. in Special Education with a concentration in Measurement and Research Methodology from the University of Arizona, U.S.A. **Dr. Abu-Hamour was a Post-Doctoral Research Associate from 2009 to 2010 for the First Things First External Evaluation Project (\$33,593,932 Grant) at the University of Arizona.** In the beginning of his career, he has awarded the College of Education Erasmus Circle Graduate Scholar from University of Arizona, the Outstanding Scholarly Research Award from Woodcock-Munoz Foundation Organization (U.S.A), and the One Year **of Seniority in Rank and Salary Award** from Mutah University for the abundance of scientific production and significant contribution to the field of special education in the Arab world.

His main area of interest is developing assessment and evaluation tools of reading, writing, math, and cognitive abilities. Specifically, he is interested in exploring cognitive abilities for students with special needs, applied measurement and assessment with an emphasis on validity analysis, and standardizing cognitive and achievement tests. For his dissertation research, Dr. Abu-Hamour investigated the relationships among various cognitive ability measures and their relationships to reading. Recently, Dr. Abu-Hamour has published more than Thirty-Six research articles, one Book, and Two book chapters related to learning disabilities, psychological testing, and inclusive education. He is the first Arab researcher who has a published chapter in American Psychological Association (APA) Handbook of Testing and Assessment in Psychology.
